

# PRODUCTION

(TO BE PROVIDED BY PURCHASER AT NO COST TO THE ARTIST)

TECHNICAL NEEDS (SOUND, STAGE, & LIGHTS)  
INNER CITY ALL STARS DOES NOT TRAVEL WITH, OR WILL PROVIDE SOUND (PA) LIGHTS OR STAGE FOR PERFORMANCES. PURCHASER MUST PROVIDE A QUALITY SOUND SYSTEM

## **PLEASE REVIEW THE STAGE PLOT AND TECH RIDER FOR YOUR CONVENIENCE**

### STAGE

Minimum Stage Dimensions 8'x 16' wide with a height of no less than 2'. Purchaser will provide a riser for the drum kit.

### HOUSE SOUND SYSTEM

Purchaser shall provide console with at least 18 channel mixers with FX, compressor, reverb, ect. 6 monitor wedges, and a front of house system that must be sufficiently amplified and in good working order. The local engineer must be familiar with the equipment

### ENGINEER

A sober, qualified, engineer or equivalent must have sound system set up in time for sound check. Remain for the duration of performance and dismantle sound system after performance

### LOADERS/STAGEHANDS

*Artist* Requires (1) Dedicated to the Inner City All Stars. Competent, SOBER, trained stage hands to unload and set up stage equipment for the performance, set change over, assist in dismantling the gear, and reloading of the truck/trailer after the performance.

### SOUND CHECK

The Inner City All Stars require at least one (1) hour closed sound check (unless show is in an open-all-the-time area) after the band & sound company is properly set up. Buyer agrees to keep non-venue employees out of the venue during sound check (when applicable).

### AUDIO AND VIDEO RECORDING

No part, portion or segment of the *Artist's* performance may be reproduced in either audio or visual form, without the express written permission of the *Artist*.

### SECURITY

Purchaser shall provide security to attend to band equipment, stage gear, (load in/load out), sound, parking and merchandising. Security placement to be determined by Inner City All Stars leader/Manager (Calvin Sexton) Security representative available to *Artists'* staff at all times.

### INSURANCE

Purchaser is responsible for and must have its' own public Liability and property damage insurance.

### BILLING

**"THE INNER CITY ALL STARS"** and not the Inner City All Stars Brass Band, must appear with the appropriate billing in all printed advertising and must be mentioned in all radio spots.

### GUEST

The Inner City All Stars will be allowed ten (10) guests, not including family members of the band, plus five (5) press list spots free admission to the venue.

### MERCHANDICE

Buyer shall provide a table and chair in a well-lit, high traffic area within the venue. *Artist* shall sell own merchandise and requires that they retain 100% of all sales. If venue requires a percentage of merchandise sales, add \$50 to artist performance fee.
